Audit Return for Local Government

Matter for Consideration

To review the Compliance Audit Return for the period 1 January to 31 December 2012.

Background

The Chief Executive Officer has prepared the on line Compliance Audit Return for the period 1 January to 31 December 2012.

The CAR is attached and results are summarised in the officer recommendation.

Areas of non compliance are reported on under Comments.

Statutory Environment

Local Government (Audit) Regulations 1996

- 14. Compliance audits by local governments
- (1) A local government is to carry out a compliance audit for the period 1 January to 31 December in each year.
- (2) After carrying out a compliance audit the local government is to prepare a compliance audit return in a form approved by the Minister.
- (3A) The local government's audit committee is to review the compliance audit return and is to report to the council the results of that review.
- (3) After the audit committee has reported to the council under subregulation (3A), the compliance audit return is to be -
 - (a) presented to the council at a meeting of the council; and
 - (b) adopted by the council; and
 - (c) recorded in the minutes of the meeting at which it is adopted.

- 15. Compliance audit return, certified copy of etc. to be given to Executive Director
- (1) After the compliance audit return has been presented to the council in accordance with regulation 14(3) a certified copy of the return together with
 - (a) a copy of the relevant section of the minutes referred to in regulation 14(3)(c); and

(b) any additional information explaining or qualifying the compliance audit,

is to be submitted to the Executive Director by 31 March next following the period to which the return relates.

(2) In this regulation —

certified in relation to a compliance audit return means signed by —

- (a) the mayor or president; and
- (b) the CEO.

s.3.1 (1) The general function of the local government is to provide for the good government of persons in its district.

Comment

The compliance annual return shows substantial compliance or complete compliance in each section. Following is a report of non-compliant areas.

- 1. One elected member failed to submit the annual return for the period ended 31 August 2012. Note that this is a repeated area of non compliance each year despite the extra efforts of staff to remind elected members. Elected members are reminded that it is your responsibility to lodge your primary and annual return by the due date, and there are substantial penalties for non compliance.
- 2. One designated staff member failed to submit the annual return for the period 31 August 2012. However, the designation of this staff member changed during the period 1 July to 31 August, and the person was absent for part of the period, and they have generally complied in previous years. This is not considered substantial non compliance.
- 3. On inspection, the tender register was found not to contain a copy of the advertisement placed by Greenfield's Technical Services on behalf of the Shire for bitumen products. Staff will obtain this document and place on the tender register. Further staff training on the tender register will prevent this recurring.
