### **Matter for Consideration**

That the Council reschedule the holding of the Annual General Meeting of Electors', to Tuesday 24 January 2017.

### **Background**

An Electors' General Meeting is required to be held after the Council accepts the Annual Report for the 2015-2016 Financial year.

Council, at the Ordinary Council Meeting held on 16 December 2016, resolved in part as follows:

"That the Annual Electors' Meeting be held at Yalgoo, at 10:00 am on Friday 20 January 2017."

Re-scheduling of the meeting to Tuesday 24<sup>th</sup> January 2017 was required in order to be compliant with Section 5.4 of the Local Government Act 1995.

### **Statutory Environment**

Local Government Act 1995

### 5.27. Electors' general meetings

- (1) A general meeting of the electors of a district is to be held once every financial year.
- (2) A general meeting is to be held on a day selected by the local government but not more than 56 days after the local government accepts the annual report for the previous financial year.
- (3) The matters to be discussed at general electors' meetings are to be those prescribed.

### 5.29. Convening electors' meetings

- (1) The CEO is to convene an electors' meeting by giving
  - (a) at least 14 days' local public notice; and
  - (b) each council member at least 14 days' notice,

of the date, time, place and purpose of the meeting.

(2) The local public notice referred to in subsection (1)(a) is to be treated as having commenced at the time of publication of the notice under section 1.7(1)(a) and is to continue by way of exhibition under section 1.7(1)(b) and (c) until the meeting has been held.

### Comment

The Annual General Meeting of Electors' was scheduled to be held at Yalgoo at 10:00 am on Friday 20 January 2017. However, it was advertised in the Geraldton Guardian and the West Australian Newspaper on Friday 13<sup>th</sup> January 2017, effectively giving only seven days' notice.

Section 5.29 of the Local Government Act 1995 states that at least 14 days local public notice is to be given. The Council, in determining the meeting date needs to also comply with Section 5.27 on the basis that the day selected cannot be more than 56 days after the Local Government accepts the Annual Report for the previous financial year being 16 December 2016.

Council is requested to give consideration to reschedule the Electors' General Meeting to Thursday 9<sup>th</sup> February 2017 in order to comply with the above-mentioned requirements.
