MATTER FOR CONSIDERATION

Future status of Burnerbinmah Road

BACKGROUND

Over the years, Burnerbinmah Road has periodically been severely damaged by rain and flood, the most recent time being early 2008 following Cyclone Nicholas.

The road is in an area crossed by many watercourses, and is part of the watershed leading to Monger Lake system, so that significant rains will always damage the road to some extent, even if not to the level of near impassibility for an extended period as earlier this year.

COMMENT

From our records and comments made, it would appear that severe damage to the road occurs on average every 7-8 years –

- 2008 Cyclone Nicholas
- 1999 as detailed in a flood damage report from Greenfield Technical Service
- 1992 approx as noted in various letters

Some responses stipulate that 1992 was the previous occasion of major damage to the road, however, this is clearly incorrect as GTS submitted a report to MRWA concerning widespread flood damage, including to Burnerbinmah Road, in May 1999.

At the July 2008 Council Meeting it was reported -

Following the May Council Meeting, and after discussion with Kim Edmeades, a desk-top options report has been requested from Michael Keane of Greenfield Technical Services which should be available in time for the Council Meeting on 19 June 2008. He has been requested to comment on the implications of –

- closure of the road, and de-Gazettal as public access
- downgrading of the road to a formed, bladed track, receiving minimal maintenance
- maintaining the road to a reasonable standard for public access
- order of magnitude costs for each option

This is only the first step in what needs to be a thorough process that is not rushed. In the same way that the Narloo-Tardie Road closure has taken quite some time, and is still not finalised, matters that need to be considered include –

- the critical legal issues
 - o liability for the road if in poor condition and remaining open to public use
 - liability for the road if signs are put up advising of four wheel drive access only
 - it should be noted that warning signs do not always absolve the Shire of responsibility or reduce exposure to liability
 - the Shire cannot remove itself from legal liability by simply proclaiming that no responsibility is accepted
 - Council cannot ignore statutory duty of care to maintain roads in a condition "fit for purpose"
 - environmental impact which figured large in the consideration to close Narloo-Tardie Road
- economic impacts on users of the road, both adverse and beneficial
- economic impact of each option on the Shire
- level of use, and by what type of vehicle the Metro Counters owned by the Shire will provide
 - o traffic count
 - o type of vehicle
 - o time, date and
 - o speed
- any strategic importance of the road that may exist as the sole access between Yalgoo Shire (Thundelarra Road) and the Great Northern Highway, between Mt Magnet and Paynes Find
- if the western end of Burnerbinmah Road was to be closed, either
 - o arrangements regarding the maintenance of the eastern section from Burnerbinmah homestead into the Nalbarra pastoral lease, which would then be isolated from access from other Shire of Yalgoo roads, but remaining Council responsibility
 - o or closure of the full length of Burnerbinmah Road within the Shire of Yalgoo

Council should also bear in mind -

- any precedents for closure of roads, such as Narloo-Tardie Road, and
- the precedent which any decision may set for future assessment of possible road closures,
- use of criteria that can be applied to any road within the Shire.

Prior to commissioning full environmental and hydrology assessments, and a detailed engineering report on the road, it is suggested that the desktop report of Greenfield Technical Services be considered, and that those with an interest in the road be asked for comment.

Responses from these organisations and individuals can then also be considered in the detailed assessments and report.

The Meeting resolved -

That prior to any decision of Council regarding the future of Burnerbinmah Road, that the comment from the following be sought –

- Main Roads WA
- Dept of Environment and Conservation
- Fire and Emergency Services Authority
- Shire of Mt Magnet
- residents of Thundelarra, Burnerbinmah and Nalbarra pastoral leases
- Australia Post
- Kirkalocka Mine

No response has been received from Australia Post, Dept of Environment and Conservation, or Kirkalocka Mine.

While not all information requested from GTS was reported, nor all responses invited received, notably the lack of response from DEC, there should be sufficient information for Council to provide some direction for the future.

Factors to be considered -

- Environmental It is readily apparent, that the western section of Burnerbinmah Rd is in an
 environmentally difficult location, and that significant rains can cause major damage to the road.
 However, there are other roads for which the Shire is responsible, where environmental damage
 occurs, such as
 - the lakes crossing on Yalgoo-Ninghan Rd
 - North Road between Jingemarra and Meka Stations
 - Greenough and Sanford River crossings
 - Salt River crossing on the Morawa Road

The main difference with Burnerbinmah Road is that it is an extended section of the road that is affected, rather than confined to a relatively small stretch or specific points.

- 2. Economic impact to two of the three pastoral stations most affected by the road is large, as closure of the section from Thundelarra homestead to Burnerbinmah homestead, would add an estimated 120 km or so each way, for a trip to Yalgoo or Geraldton, from Burnerbinmah. It would be less for Nalbarra, but still add 80-90 km each way to a Geraldton trip.
- 3. Economic benefit to the Shire of Yalgoo if the western section was to be closed, is mixed. While no maintenance would be needed on this section, as it is closed, the eastern section providing access to Burnerbinmah from the Great Northern Highway, would remain open, with about 20 km of the road east of Burnerbinmah homestead, still being the responsibility of Yalgoo to maintain.

The road could be maintained by -

- Shire of Yalgoo necessitating mob/demob of graders either through Mt Magnet or Paynes Find
- make arrangements with the Shire of Mt Magnet to maintain the road, or
- use contractors based in the eastern part of the Shire to maintain.

Two other possibilities exist -

- i) closure of Burnerbinmah Road from the Shire of Mt Magnet boundary to Thundelarra homestead, effectively isolating Burnerbinmah homestead from access. This would create a "one-off" situation where Burnerbinmah would be the only homestead without direct access to a public road. This is similar to farms in the agricultural area, where public access is only required to be provided to the property boundary, not to the residence.
- ii) amend the boundaries between the Shires, and transfer Burnerbinmah Station to the Shire of Mt Magnet, so that the road becomes their problem, although this would require the consent of Mt Magnet. This would still leave the part of Burnerbinmah Road that is in the Thundelarra lease within our Shire.
- 4. Level of use no traffic counts have been taken on the road, although it would be a reasonable estimate that Average Daily Traffic is probably in the order 10 or less, with most being cars or 4WD and very few trucks or road trains.
- 5. Grant funding MRWA have indicated in discussion, that if the road remains open, future flood damage / repair may not be funded. Accordingly, if this came about, Council would be responsible for the full cost of repair. Following Cyclone Nicholas early this year, the cost of repair is likely to be in the order of \$40,000-\$50,000.

However, their letter states -

Main Roads will continue to support the Shire through he Regional Road Group, but has no comment to offer in relation to the future use of Burnerbinmah Road.

Significant amounts were spent on Paynes Find-Thundelarra Road, Yalgoo-Ninghan Road, North Road, Unanna Hills Road, Dalgaranga-Cue, Greenough River Crossing and other as the result of

floods over the past few years. Burnerbinmah Road is not the only road that costs a lot to repair after rains.

The Grants Commission does allocate funds according to road lengths, type of construction etc. Closure of the western section would result in the grant being reduced by a negligible amount, perhaps as much as \$150-\$200.

Precedent

The closure of Narloo Tardie Road, cannot be used as a precedent to justify the closure of the western section of Burnerbinmah Road, since –

- the closure of the Narloo-Tardie Road was requested by the lease holder
- the closure was supported tacitly by other lease holders who may have been affected, in that there was no objection to the closure when comment was invited
- a viable alternative route was available
- the alternative route does not add significantly to either distance or time travel time.

Should the western section of Burnerbinmah Road be closed, the possibility of precedent for other very low use roads, serving only one or two homesteads, needs to be considered. Depending on the criteria used to justify closure, a precedent could be argued for almost every road in the Shire.

History could be seen as a precedent for the road to remain open. However, as with almost all aspects of Shire operations, history is a poor excuse for validating why or why not, a thing should be done or not done, continued or not continued. Every aspect of Shire operations should be scrutinised from time to time a decision made as to whether or not it contributes to the benefit of the community. Over the years, there has no doubt been many matters that have been examined, and while the past usefulness is not disputed, the value of continuing it into the future has been judged to be inadequate.

Responses received

Responses received are attached in full. While many of the reasons given are the result of personal choices, they are of importance to the person making the submission. Some reasons, such as for providing access between stations, are not effective, as there are multiple access points between adjoining neighbours, that do not rely on public road access.

The matters considered relevant to the Shire for consideration are -

- (i) it is not the full western section, but only 10 km (approx.) that is prone to damage
- (ii) a core function of Shire is to provide roads for many purposes -
 - supplies to stations fuel, mail, goods and services, contractors
 - tourism
 - emergency services etc
- (iii) the road provides the only access between the central region of the Yalgoo Shire and the Great Northern Highway
- (iv) the Shire has an obligation to consider impact and benefits, not only to residents in general, but also those specifically affected and relying on the road
- (v) access routes are important to retain and maintain for emergencies, and Golden Grove is both a potential hazard area, as well as potential resource. If closed, transit times to/from Mt Magnet could increase significantly.

Liability

As noted at the July 2008 meeting and repeated earlier in this item, there are critical legal issues –

- liability for the road if in poor condition and remaining open to public use
- liability for the road if signs are put up advising of four wheel drive access only

It should be noted that -

- warning signs do not always absolve the Shire of responsibility or reduce exposure to liability

- the Shire cannot remove itself from legal liability by simply proclaiming that no responsibility is accepted
- Council cannot ignore statutory duty of care to maintain roads in a condition "fit for purpose"

Summary

Much has been made of the Triple Bottom Line as justification for government or organisational actions over the years. Many are now arguing for a Quadruple Bottom Line, which could be defined as –

The balanced sustainability resulting from the simultaneous advancement of -

- 1. Economic prosperity
- 2. Environmental or ecological integrity
- 3. Social equity / commitment –means appropriate standards of governance, and reasonable access to resources, services and facilities ¹
- 4. Community the intangible but real, sense of belonging, ownership and satisfaction; community well-being as expressed through creativity, diversity of cultural expression and innovation ²

Although there are environmental and economic costs of the road remaining open, there are large economic, social and community costs if the western section of Burnerbinmah Road was to be closed.

MATTER FOR CONSIDERATION

Future use and standards of Yalgoo-Morawa Road

BACKGROUND

Increase in traffic on the Yalgoo-Morawa Road has been noted, particularly of road trains and other heavy vehicles. As 45 km of the road in Yalgoo Shire is unsealed and most of this stretch is natural surface, wet conditions can result in traffic conditions changing quickly, and when dry it can be rutted with corrugations and potholes. In the dry, the binding material in the surface can be quickly dissipated by traffic, leaving drifts of loose stone on curves and at the side of the road.

STATUTORY ENVIRONMENT

Local Government Act 1995 -

- s.3.1 – Provides that the general function of the local government is to provide for the good government of persons in its district.

Public Works Act 1902 -

- s.86(3) – roads under the control of local governments

STRATEGIC IMPLICATIONS

COMMENT

The Morawa Road is probably the most closely scrutinised road under the Shire's control, and seems to attract constant criticism regarding its state, with complaints being received almost every Council meeting. Much of the criticism I consider over-stated, particularly when the road is compared to other roads within the Shire that have a higher traffic count or carry a higher proportion of heavy traffic.

The road is most definitely not always perfect, however, it is not a bitumised road, and much of it is still natural surface, narrowing at points and winding. It should be expected that corrugations will appear, that there will be drifts of loose stone on curves, and that "railway tracks" will develop on the straight stretches. The road needs to be driven with its characteristics in mind.

To maintain Morawa Road so that a 110 km/hr speed can be maintained at all times, would be a waste of resources, and would then result in other roads suffering a lack of maintenance, to make up for the overattention paid to Morawa Road.

The Shire is responsible for nearly 1,500 km of road, of which about 100 km is bitumised. Other important sections that need to be constantly watched include –

- Thundelarra-Paynes Find Road
 - o at the northern end to south of Burnerbinmah Rd
 - o through Fields Find, and
 - o the lake crossing Paynes Find side of Old Warriedar Rd
- Yalgoo-Ninghan Road
 - o over the lakes
 - o through hills north of Warriedar
- North Road just inside Meka Station southern boundary
- Greenough River crossing

Last 3 years

With the criticism that the Morawa Road and other roads not being maintained to an adequate standard in recent times, Council needs to remember a number of important factors –

- the works crew is small we don't have spare staff, so when one or two are absent, or there are vacancies, the works can be substantially affected. To expand the crew to cover absences, vacancies or an increased workload means that significantly more resources (i.e. rates increases, as no extra grants are available) would be needed. The provision of extra resources to do this is at Council's discretion. The alternative would be to use contractors more extensively for either construction or maintenance or both.
- the works crew has a high standard— we regularly get comments about the effectiveness of the Works Supervisor in managing the crew and the standard of completion of the work.
- the works crew has been very busy in early 2006, the tail end of a cyclone caused havoc in the north part of the Shire, so much so that for nearly 18 months, the works crew did little other than flood damage works. In late 2007, two series of storms damaged large sections of roads that the crew had spent 18 months fixing. Early 2008, the crew fixed roads that had previously been fixed several times, as well as attended to significant damage to roads through the south east of the Shire after Cyclone Nicholas, and then storms a few weeks later, once again. There are roads in the north that have been graded at least 4 times in the past 12-15 months due to storm damage, and graders stranded on the wrong side of the Greenough and Sanford Rivers on at least 3 occasions.
- the amount of flood damage works that has had to be done effectively delayed the road construction program by 2 years. In 2007, the crew did 13 km construction of the Yalgoo-Ninghan Road and 6-7 km on the Morawa Road, to try to catch up with grant works that had been deferred. The flood damage work meant that full maintenance has not been able to be done consistently since early 2006.
- maintenance has therefore suffered, not because of a lack of experience, but simply because the works crew has been overloaded. In the past 12 months, in order to try to assist to getting back to a normal maintenance program, and get all construction works up to date so that grants may be claimed, contractors have been used on a number of occasions. Contractors should probably have been used earlier and more extensively so that maintenance and construction work was not delayed more than necessary.

In summary -

- we are only now getting to the point where almost all flood damage work is done
- with the construction backlog cleared, and
- the only construction work now to be done, is this years work

Road condition

After last council meeting the road was inspected. My comments -

- went over it at 110 km/hr no problem, rough but reasonably fit for purpose, and not considered dangerous, some quite deep creek crossings/potholes, but generally easily seen and avoided
 - Worst section seemed to be from the north Mellenbye access road to boundary, but other small sections also not good – e.g. Salt River crossing, 2 creek lines near the southern Barnong entry at Gullewa
- return, mostly at 90+ km/hr, during evening/night no problem, but felt rougher than trip down (direction of loaded trucks),

 Worst spots were floodway 4 km south of Gullewa, 4 km off end of bitumen, creeks near Barnong.

In discussing the road with the Works Foreman, he noted that deterioration of the Morawa Road and other roads, is in part due to being unable to crown the road properly –

- need a roller to build the crown in multiple compacted layers in order to build up the centre of the road 150-200 mm
- the current self-propelled multi-tyre roller is too heavy, and too slow. These S/P M/T 16-17 tonne rollers have constant Issues with brakes, clutch and the engine overheating. For all their lack of speed, I recall more serious accidents with rollers than any other road making equipment. It is the right machine for construction where only one or two passes might be needed at a time over a relatively short distance, but for maintenance roadwork, the ability to roll constantly over long distances would be very advantageous.
- the ideal roller for maintenance would be 8-12 tonne travelling at same speed as graders, so that the surface is compacted with each successive layer. There are three options
 - an S/P roller which would then need an operator, and possibly accommodation etc.
 Estimated cost \$140,000 + new
 - a towed behind roller in a grid or smooth drum combination. These are built in South Australia, and cost is in the order of \$85-90,000 new. It would be much cheaper if just the multi-tyre option.
 - Free-roll attachment to the rear of the grader issues with these is that maximum rolling weight is less that 3 tonne, and if a relief valve is not fitted, when grading through dips and drains, the drive wheels can lose some traction.

One problem with the towed behind option, is that WALGA have recently advised that grader are not permitted to tow equipment, as there are no manufacturers' specifications. It is assumed that this same prohibition would also apply to loaders. WALGA, Dept of Planning and Infrastructure, Main Roads WA and manufacturers are currently trying to resolve this matter, so that graders can legally tow caravans, rollers, fuel tankers etc.

The Works Foreman has particularly noted the need to slow down trucks, if they are to continue using the road, even on the sealed section since it is only single lane. Much of the corrugations appear to be caused by the additional bounce of empty trailers. Main Roads have advised that maximum legal speed of a road train on the road is 80 km/hr.

Effects of withdrawing permission for road trains

If road trains are put off the Morawa Road, there are a number of impacts –

- positive impacts
 - o heavy vehicle traffic substantially reduced, whether loaded or unloaded
 - o possible significantly extended times between maintenance being required
 - o improved road safety for travellers in cars etc, from stones being thrown up etc
- negative impacts
 - reduced traffic counts resulting in eligibility for grant for road funding being deferred, probably for many years
 - impact on the Shire of Morawa whose section of road has just reached the necessary counts for grant funding
 - extended drive time and distance for road trains coming using the road resulting in additional fuel cost and driver fatigue
 - would most likely mean that the Shire of Yalgoo also, could not use the road for road trains either for construction and maintenance work, or for transporting to/from Perth, without MRWA approval.
 - while the Shire is responsible for the road infrastructure, it is MRWA that issue the permits and certify routes for road trains, after seeking Council comment.

The route would remain open for single trailer semi's, and rigid trucks towing trailers, as these are as of right vehicles, and are not subject to MRWA approval or road train speed limits. It is possible that to reduce the distance travelled between Morawa and Yalgoo, that transport companies may ferry trailers across the "disallowed" section, instead of having to go through Mullewa, thereby increasing traffic.

Shire of Morawa

Morawa CEO, Gavin Treasure, verbally advised on 19 August 2008, that -

- they are keen to seal the remaining 15 km in their Shire
- sealing will take about 5 yrs at approx. 3 km per year
- they are only doing a single lane seal 4 m wide
- thinks that approval of individual trip or purpose may be an option, and could be manageable/ preferable
- if a standing permit given, needs to be some contribution to road construction/maintenance

Following receipt of our letter requesting comment, he subsequently advised that he would be taking the matter to their September meeting for a formal response, which should be available for the Council meeting.

While Council's concern is particularly for our stretch, we do have a need to consider impact on neighbours, particularly Morawa. Yalgoo needs to work in cooperation with them on this matter.

Options

- continue as we have been
 - o put up with the complaints, do full maintenance twice a year, touch up grading in between, and urgent maintenance as needed
 - o seal 3 km each year 15 yrs to complete
- management options
 - o reduce legal limit to 90 km/hr for vehicles under 15 tonne GVM, for safety
 - reduce legal limit for vehicles over 15 tonne GVM to 70 km/hr, to reduce road damage
 - put road trains etc off the road
 - issue of enforcement without someone sitting out there waiting, the possibility of effective enforcement is negligible
- bitumise our 45 km unsealed section as single project -
 - business case needed
 - would need extra person and equipment to ensure maintenance work in the rest of the Shire can carry on without interruption
 - alternatively, put the project out to contract (possibly more expensive)
 - likely 12 month project if undertaken by Shire staff
 - o reseal in 15 or so years time would be a very large funding issue
 - a loan would be required, and loan repayment costs would not be considered eligible for either Regional Road Group or Roads to Recovery funding
 - o compare with cost to continue 3 km seal for 15 years + LGCI each year
- with MGM doing up Wanarra East Road, this could become the preferred route for Winchesters to Mt Magnet and the areas north and east of Mt Magnet. According to the Works Foreman, they used to use it, and it was only when the road deteriorated to its current poor condition and single vehicle width, that they discontinued.
 - the Shire of Yalgoo does have contractual obligations to MGM to negotiate with any new constant user for a contribution to maintenance.
 - Wanarra East Road should be constructed to an 8 m seal width for Extension Hill, within the next 6-8 months.
- request through MCZ that WALGA pursue ability for Councils to charge a fee for permits to use road trains or concession permits, if no other arrangements in place.
- many Shires are negotiating with mining companies particularly, agreement for contributions to construction and maintenance of roads.
 - o Mt Gibson Mining Extension Hill and Tallering Peak
 - OZ Minerals
 - o Gindalbie
 - Mid West

It is equitable that frequent carriers also be required to contribute. However, the issue of how to require them to make a contribution must be addressed, and there is currently no legal mechanism to do so. In the case of most mining companies, they have required roads to be substantially upgraded, and this is the cost that is imposed on them, as well as continued maintenance at this higher standard. If they used as of right vehicles, full cost of making the road fit for purpose would be the responsibility of Council.

Option – 45 km construct and seal project

As a very rough estimate, the cost to construct 1 km of road and seal to 4 m wide is \$80,000. Allowing \$20,000 per km for additional works (rockbreaking, draining, realignment etc), a base cost of \$100,000 for 1 km or \$300,000 for the annual 3 km construction work is used for estimation purposes.

At 3 km per year, another 15 years is needed before the road would be sealed its full length. Assuming an annual WA Local Government Construction Cost Index rate of 4.5%, then –

If considered as a single 12 month project, and discounting the several passing opportunities already sealed the rough cost of constructing and sealing the 42 km to the boundary with the Shire of Morawa, after 2008/09 construction is –

The total cost of a loan for \$4.5 million at 6.42%, over 15 years with repayments of \$237,200 every six months is \$7.116 million, quoted by WA Treasury Corporation on 18 September 2008. One amount of \$150,000 for the 2009/10 work could also be needed to be factored in, for a total cost –

\$4.5M loan repayments of \$237,200, half yearly for 15 years =
$$\frac{7,116,000}{150,000}$$

Add 2009/10 from Councils own resources = $\frac{150,000}{1000}$
Total cost say = $\frac{150,000}{1000}$

Estimated 15 year cost of single year project funded by loan = \$7.27 million Estimated 15 year cost of doing 3 km construction annually = \$6.25 million

On face value, if the work was done as a single project, it would appear that the potential additional cash cost is in the order of \$1 million over the next 15 years, or about \$67,800 per year. Any saving as a result of reduced maintenance requirement would be an offset, perhaps 15 days per annum at \$3,000 per day, or \$45,000 per year. The net additional cash cost per year could be as little as \$25,000 to \$30,000.

PLEASE NOTE -

- 1. loan repayments do not qualify for funding under either Roads to Recovery or Regional Roads Group. The only road therefore likely to continue to remain eligible for both grant funding programs would be the Yalgoo-Ninghan Road.
- 2. by doing the work as a single project, also means that there is a large future obligation for reseal in 10-15 years time, that would need to be completed over the space of a couple of years. Funds would need to be put aside annually for this work, and may mean making loan repayments and funding reseal cost in the same year.
- 3. reseal on the currently sealed 29 km section of the road is due to commence before 2023
- 4. it would be imperative that a Reserve fund is created specifically for this task,
- 5. also essential is that Council's commitment on the Yalgoo-Ninghan Road is considered and factored in, as the sealed length extends from its present 70 km approx.

- 6. In discussion with Michael Keane of GTS on 17 September, he -
 - expressed some concern at the long term continuity of R2R funding, beyond the current government commitments. If R2R was to be discontinued, the Shire's roadworks could need to be significantly curtailed, as funds would already committed to loan repayments.
 - commented that as traffic increases, the road will become eligible for consideration for grants. By constructing and sealing as a single project, it would remove the road from consideration until such time as reseals are needed. However, grant funding for the road is a competitive process with other Shires in the RRG, and being eligible is not a guarantee of funding. Applications for funding consider traffic counts, safety issues, type of traffic, weighted according to need and urgency of the work, and then compares these factors against applications from other Shires.
- 7. loan rate movements prior to commence may have a big impact on any estimated viability

Prior to pursuing this option, it is strongly suggested that Greenfield Technical Services be requested to make a full costing of the project, identifying any flow on effects to other Shire work, e.g. additional extra staff needed for the duration of the project, early purchase and/or delayed disposal of plant, use of contractor as an alternative to Shire staff constructing the road, etc.

COMMENT

The EHO is currently on annual leave, but will be available at the Council meeting to provide more detailed comment and to provide advice as to next steps, amendments needed, timeframes etc.

The LPS No.2 will replace the Town Planning Scheme No.1 once Gazetted. Substantial changes to legislation and terminology have occurred since 1992 when the current Scheme was endorsed. Two major changes are that the Scheme must now cover the whole of the district, whereas previously, it could apply only to towns, and secondly, the requirement for a Strategy to be adopted.

The Strategy is about the future directions for the district that are intended by Council. While it is mandatory to produce the document, compliance with it is not obligatory, although it needs to be highly regarded as it is the principles that Council will apply in considering development. The principles of the Strategy are embedded in the Text, which is mandatory.

The Text is the rulebook, the "how to" and "what to" document. The Text has similar status to Regulations made under an Act of Parliament, as it is subsidiary legislation to the Planning and Development Act. While

Council does have discretions in the Scheme, compliance is obligatory on all developers and land users, including the Shire.

Notice of the review of the Scheme was advertised for public comment, and invitations were sent to the required organisations as notified by the Dept for Planning and Infrastructure, including –

- Dept for Indigenous Affairs
- Water Corporation
- Heritage Council of WA extension of time sought until the Council meeting in which to respond
- other Government departments and agencies that may be affected.
- surrounding Shires
- no public comment has been received.

The draft Text and maps were reviewed by the EHO and myself prior to him going on annual leave, and the following comments are made –

Text

- a) p.15 in Table 1 insert in order that dog kennels are prohibited in all zones of the Shire, consistent with the Shire's Dog Local Law.
- b) p.15 in Table 1 (and elsewhere if necessary) delete all reference to "Townsite" as a Zone. This Zone was originally in TPS No.1, and applied outside the Yalgoo Townsite to Paynes Find mainly. However, as Paynes Find is not a Gazetted Townsite, the use of the Zone was omitted in the LPS No.2 revision maps, but inadvertently left in the Text. Removal of the Zone is consistent with and reflects the purposes noted on the maps.
- c) p.15, Table 1 uses in other Zones needs to be considered in detail
- d) p.45, clause 2 *Land use definitions* insert definition of "*dog kennel*", consequent to the prohibition to be inserted into Table 1 by (a) above, and consistent with Local Laws.

Strategy

- a) p.50, LPS Policy No.2 delete the sentence "A caretaker's residence shall only be permitted at the rear of a lot zoned Industrial". There could be very good reasons for having the residence at the front of the lot (e.g. a shorter driveway so more land for industrial use, improved security for site, allows supervision of the site without having to enter the site etc).
- b) p.60, LPS Policy No.5 delete the draft Policy for Disposal of Effluent within the Yalgoo Townsite completely. The Policy recommends use of Aerobic Treatment Units instead, however, since the Policy was drafted, use of ATU's has occurred in several locations around town, with major problems of maintenance, servicing, reliability and continuity of operation being experienced. Removal of the policy will not prevent the use of ATU's, but does revert to the requirement that disposal of effluent must comply with the Health Act.

- a) Maps as advertised, need to be updated to ensure zoning and land use details reflect the actual details of use, as per the most recent WA Planning Commission maps of November 2007
- b) Roads and road alignment details to be verified with Main Roads WA State of Construction maps, as some roads are not marked, some are not marked in full, and some show and incorrect alignment

 - Need to ensure appropriate changes are made to the Text and Maps
- d) State Land Service (DPI) no amendment requested
- e) Tourism WA requesting that due consideration be given to the Tourism Planning Taskforce Report, but recognising that this Report is unlikely to have impact on the Shire.

- The Report focuses on planning in areas where there is a high demand and pressure for tourism development (hotels, restaurants, tourist facilities etc) such as Busselton, Esperance, Geraldton, Coral Bay, Shark Bay etc. The Report asks that the Shires in these areas give particular consideration to the growth of the tourism industry, and the pressures it bring to cater for demands on that locality.

The Zone welcomes observers from member Councils.

As noted earlier in this Agenda at item 11.1.3 Yalgoo-Morawa Road, it is suggested that the issue of Council's being able to impose a fee on road trains for permission to use Local Government roads be raised.

It is further suggested that the issue of Telstra service (or lack thereof) in country areas be raised. Telstra have been constantly queried regarding their lack of service in many areas, both internet and mobile phone without success, over a number years. Council did write to Mr Peter Fairclough, Managing Director, Telstra Countrywide for WA, but his response essentially was that once their Customer Service Obligations are met, if it is not economic, mobile and internet development is not going to happen unless paid for by the customer. In effect, the CSO's placed on Telstra are now being used to justify why a service should not be improved.

In Yalgoo, we have also been waiting for resolution of telephone lines for internet into the admin office and HCP office for 12 months now. Phone calls to Telstra for information, and to try to get some action and resolution to queries and problems are either not returned or are of no assistance. It has reached a point where there seems to be little point in trying to get them to do anything. One division of Telstra claims that the lines we have requested at the office are going to be out of date or not available, however, as far as we cal work out, the same type/standard of lines were installed at the Old Railway Station for the video conferencing room.

Telstra's intransigence is well recognised in country areas, in Government agencies, business, local government, commercial travellers, contractors and private individuals.

I did make a submission to the Federal Government's Telecommunications Independent Review Committee earlier in 2008, following letters to State and Federal politicians. The Mid West Development Commission through Brendin Flanigan and Mark Kanny, are well aware of our problems and have been active in supporting our requests where able, to Dept of Industry and Resources including arranging a visit by DOIR to the region, and putting forward our views to telecommunications user groups.

There's two aspects of Telstra operations that really grind salt into the wounds –

- the constant half price, free for six month, get connected to Bigpond and get a free mobile offers that they make, that we cannot access
- Telstra prepaid mobile salespeople calling the local shop asking them why they won't sell mobile phones and pre-paid vouchers

Without some sort of stick to beat them with, it seems that Telstra are willing to shrug off all complaints on the grounds of having met their CSO's and therefore don't need to do anything more, and that it is not economically viable for them, so they can't afford to do anything more.

Telstra have a preferred supplier arrangement with WA Local Government Association. While their call rates are excellent, the service standard of Telstra and their contractors is very low.

Accordingly, it is suggested that WALGA be requested to either –

- remove Telstra as preferred supplier to Local Government on the basis of continuously substandard service to country areas, or
- alternatively, arrange a second preferred supplier contract for country areas.

For internet particularly, there may now be viable alternatives to Telstra, being Optus, the second largest internet service provider in Australia, and the recent acquisition of Westnet by iiNet, making them the third largest ISP.

COMMENT

Cr Anderson has requested that this matter be considered by Council again. At the August 2008 Council Meeting it was reported –

In considering rental of the house to the MWHR, Council needs to be aware of several matters –

- although two new houses are due in the very near future, the only unoccupied accommodation is now one of the six units, which will be required for the PA,
- the unit that Greg Daniel is occupying will not become available until January 2009,
- several staff have enquired about availability of the house.

The MWHR are keen to explore possibilities for the development and improvement of facilities in Yalgoo, but are unable to commit to construction or a long term arrangement without definite proposals. These options will take time to prepare, but in the meantime, they do wish to improve the arrangements for the Community Nurse.

Following discussion and negotiation with the Mid West Health Region, it has been agreed (subject to final confirmation by Council), that –

- the house would be rented from the Shire for an initial period of 2 years,
- rent amount is \$155 per week, being the market rental as assessed by Ray White Real Estate Geraldton
- the rent would be fixed for the initial 12 months of the rental, to be reviewed at the end of this time for the concluding 12 months
- rental agreement as per the Residential Tenancies Act
- the Health Dept to be responsible for the maintenance of the grounds and out-goings (power, water, phone etc)

During this 2 year period, the Shire and the MWHR have the opportunity to discuss -

- future of the current Nursing Post to be determined by Health Dept,
- refurbishment of the existing Nursing Post or development of a new Nursing Post and/or accommodation, to be negotiated between Health Dept and Shire, if identified,
- long term lease/rent of the house to be considered, based on outcomes of the above points.

In regards to a long term arrangement (say 15-20 years), the main issue identified at this time to be addressed, is that the Health Department does not end up paying for a Shire asset. That is, any lease or rental will need to take into account that if a capital component is included in the agreement, then the Health Dept would require equity in the asset in their favour, to be recognised and provided for.

Subject to this, they are very interested in pursuing possibilities for a partnership, and accept the principle of cost neutrality to the Shire as outline in Point 2 of the April 2008 resolution.

The recommendation and subsequent amendments at the August 2008 meeting, was lost when put to the vote. The effective motion that was lost was –

That -

- Lot 27 Stanley Street be rented to the Health Department for an initial period of one year,
- the commencing rent amount be \$300 per week,
- the rent be fixed for the initial 6 months of the period, to be reviewed at that time for the concluding 6 months
- the rental agreement be as per the Residential Tenancies Act
- the Health Dept to be responsible for the maintenance of the grounds and out-goings (power, water, phone etc)

Reference was made to the Department of Local Government as to whether further consideration of this matter constitutes a revocation of a resolution of Council made at the August Meeting. DLGRD advised that as the previous motion was defeated, rather than carried, that there is not a resolution to be revoked. It constitutes withholding approval for the lease, rather than directing that a lease not be considered. DLGRD did suggest that revocation requirements be followed as possible.

The only variation of note to the previous report is that all accommodation is now occupied, as Mrs Christine Massage has been appointed to PA / Executive Support Officer. She and her family will be taking up residence at Unit 18B Shamrock Street on or about 24 September 2008.

The new houses on Henty and Campbell Sts should be ready for occupancy within the next couple of weeks.
