5.0 FACILITIES

6.0 RACING AND WAGERING WA (RWWA) BUSINESS

The race day programme has been received from the Department of Racing and Gaming WA. Six TAB race events have been scheduled.

6.1 INFRASTRUCTURE AT YALGOO SPORTING COMPLEX

The Yalgoo Sporting Complex is listed as a State Heritage building requiring approval to make any alterations to the building.

Therefore, in order to install the required camera tower, stairs and Jockey change rooms, quotes will be required for the hire of these facilities.

Due to recent adverse weather damage, repairs to the Sporting Complex ceiling and an internal door are required.

An insurance claim has been lodged by the Shire of Yalgoo and quotes for repair will be obtained from Mr Keith O'Connor in order to have the work completed by race day.

6.2 BARRIER REPAIRS

The race course barriers have been damaged by storms.

The repairs have been assessed and will be painted/repared by a combination of Shire workers, a local working bee and possibly by MEEDAC.

6.3 TOTE

A new Tote Manager and staff are required for the race day meeting.

Previously this work was conducted by members of the Mt Magnet Racing Club.

Volunteers are also required to man the horse Starting Barrier at each race.
This job is physically demanding.
