#### Matter for Consideration

Council to confirm that rate in a dollar for the differential rate category - UV Pastoral /Rural Category.

#### Comment

In accordance section 6.32,6.33 and 6.36 of the local government act 1995 the proposed differential rates and minimums were advertised at the close of advertising one submission was received and considered by council at its meeting held 27 July 2018 were council resolved to proceed and seek ministerial approval.

An application was subsequently made to the Minister. The Depart of Local Government, Sports and Cultural Industries has informed the Shire that the rate in the dollar for the rural and pastoral category proposed by the Shire differed to the rate advertised. Council is now requested to correct the error as to the rate in a dollar proposed for this category to equal the advertised rate in the dollar of 0.0677242

Information had been received from the Department of Local Government, Sports and Communities on the afternoon of e 30 August and therefore additional amendments have been requested to the 18-19 Annual Budget and rating categories.

Therefore Council is requested to apply for an extension to the Minister for the adoption of the 18-19 Annual Budget to the Friday, 14 September 2018 and for the president to arrange for a special meeting to be held on this day.
